

Competition Terms and Condition:

Please read these terms and conditions carefully. Participation in this Competition is governed by these terms and conditions ("the Rules").

This promotional competition is conducted by Pentel South Africa (Pty) Limited, Registration No. 1983/008399/07, 96 Shaft Street, Cnr Ratchet Avenue, Stormill Ext 3, Roodepoort ("the Promoter" or "Our" or "Pentel") and Office National Africa (Pty) Ltd, Registration No. 2005/010011/07) with support office situated at the corner of Ridge Road and Vlagskip Street, Laser Park, Honeydew ("the Promoter" or "Our" or "Office National") hereby offers the opportunity to participate in "Win 1 of 4 Orbit Scooters with Pentel and Office National" Competition ("the Competition"). Participation in the Competition constitutes acceptance of these Rules and Participants agree to abide by these Rules.
